## **DBA Program Outline**

#### **Doctoral Program Design**

The doctoral program consists of two major parts: the **pre-dissertation stage** and the **dissertation stage**.

The pre-dissertation stage objective is to provide the student with the theoretical foundations and practices of the primary and supporting fields of study and with a command of relevant qualitative methods of research and analysis.

The dissertation stage objective is for the doctoral student to apply the theoretical and practical knowledge and analytic methods to the resolution of the research program.

#### **Study Plan**

- **Pre-dissertation Stage:** (First 12 months) 1 module per month.
- Dissertation Stage:

The objective of the dissertation stage is to demonstrate that the doctoral student has synthesized the knowledge gained during the pre-dissertation stage and can apply this knowledge to the resolution of a substantial problem.

- **Part 1:** (2 months) Two seminars are compulsory to be attended by all DBA candidates in one of the following cities: Istanbul, Dubai, Muscat, Yerevan, Zurich, and Copenhagen.

- Part 2: (minimum 15 months) Dissertation
